

End User Software License Agreement

This is a License for Software to be downloaded from the Tridium app store in JAR format and solely for use on a Java Application Control Engine (“Jace”) sold by Tridium, including any Updates and Revisions (collectively referred to as the “Software”), and effective upon your payment of the License Fee and your downloading of the Software.

This End User License Agreement sets forth the terms and conditions of the license for the Software provided to you. DIVERSE CONTROLS, INC. (“Company”) grant to you a nonexclusive and nontransferable license to use the Software in object code form on a single JACE owned or leased by you or otherwise embedded in equipment provided by Tridium. You may not modify or change the Software. The software will be downloaded by you electronically from the Tridium app store.

EXCEPT AS EXPRESSLY AUTHORIZED ABOVE, YOU SHALL NOT: COPY, IN WHOLE OR IN PART, SOFTWARE OR DOCUMENTATION; MODIFY THE SOFTWARE; REVERSE COMPILE OR REVERSE ASSEMBLE ALL OR ANY PORTION OF THE SOFTWARE; OR RENT, LEASE, DISTRIBUTE, SELL, OR CREATE DERIVATIVE WORKS OF THE SOFTWARE.

You agree that aspects of the licensed materials, including the specific design and structure of individual programs, constitute trade secrets and/or copyrighted material of Company. You shall not disclose, provide, or otherwise make available such trade secrets or copyrighted material in any form to any third party without the prior written consent of Company. You shall implement reasonable security measures to protect such trade secrets and copyrighted material. Title to the Software and any documentation delivered shall remain solely with Company.
