

END USER LICENSE AGREEMENT

IMPORTANT: PLEASE READ THIS LICENSE CAREFULLY BEFORE USING THIS SOFTWARE.

1. LICENSE

By receiving, opening the file package, and/or using our drivers ("Software") containing this software, you agree that this End User License Agreement (EULA) is a legally binding and valid contract and agree to be bound by it. You agree to abide by the intellectual property laws and all of the terms and conditions of this Agreement. Unless you have a different license agreement signed by Inlon Engineering Srl your use of our drivers indicates your acceptance of this license agreement and warranty. Subject to the terms of this Agreement, Inlon Engineering Srl grants to you a limited, non-exclusive, non-transferable license, without right to sub-license, to use our drivers in accordance with this Agreement and any other written agreement with Inlon Engineering Srl. Inlon Engineering Srl does not transfer the title of our drivers to you; the license granted to you is not a sale. This agreement is a binding legal agreement between Inlon Engineering Srl and the purchasers or users of our drivers.
