

Sales Terms & Conditions – End User License Agreement (EULA) – PLEASE READ BEFORE INSTALLING AND USING THIS SOFTWARE.

1. GENERAL: 1.1. Malvar Controls, Lda. (hereinafter referred to as MALVAR) is responsible for Malvar products presented on Niagara marketplace. 1.2. This agreement is a binding legal agreement between MALVAR and the purchasers or users of this software.

2. ORDERS, INVOICING, PAYMENTS: 2.1. Niagara Marketplace conditions apply. 2.2. Orders in progress may be blocked or canceled by MALVAR in cases of force majeure, namely, delays in payments for previous supplies, financial problems of the Customer, product discontinuity, delivery delays by suppliers and/or carriers, etc. 2.3. Orders in process cannot be canceled by the Customer without MALVAR's prior written acceptance.

3. PRODUCT LICENSING CONDITIONS: 3.1. When downloading, copying, installing and/or using MALVAR software, you agree with this End User License Agreement (EULA) as a legally valid contract and agree to be bound by it, including the intellectual property laws and all the terms and conditions of this Agreement. 3.2. Ownership of MALVAR software is not transferred to the purchaser and/or the user. 3.3. Based on the terms of this Agreement, MALVAR grants a non-exclusive, non-transferable software license. 3.4. The software and license granted by MALVAR cannot be transferred, copied, shared, distributed, re-sold, or sub-licensed, with the only exception of copy for archive purposes. This applies to the complete software and license or part of it. 3.5. If you do not accept the conditions of this agreement, you must remove MALVAR software from your computers and delete any existing copies of the software. Any packaging and documentation must be also returned to MALVAR.
